











The City Planning Departments of Urban Local Bodies are required to approve plans before buildings are constructed. This is applicable to all types of buildings including commercial, residential, industrial, etc. Plans should adhere to zoning regulations and other stipulations.

The Building Plan Approval application of the DIGIT platform, one of the components for a smart city, provides a single window for getting permits, NOCs and clearances from multiple agencies.

Increased transparency


All the stakeholders — including citizens, business users, ULB officials — are on one platform. Real-time synchronization of process, including status updates between all end-users.
